Non-Profit Organization Expectations

Being a part of the Levy Volunteer Team at Cleveland Browns Stadium is a season long commitment. There are minimum expectations that we ask of each organization so that we may provide consistent service to all of our guests. All minimum expectations must be met prior to allowing an organization to participate in an event.

Volunteer Requirements

All volunteers must be at least 18 years of age to participate at Cleveland Browns Stadium. Anyone selling or serving alcohol must be at least 21 years of age and must attend all required training sessions.

We have something for every size organization, large or small. If you know of another organization that you would like to partner with to fill a stand or you would like Levy to partner you with another group please let us know. If your organization has enough volunteers to fill more than one stand, we can certainly consider it!

Paperwork Requirements

All paperwork must be completed prior to volunteering. Each organization must have all necessary paperwork completed and turned in before participating at any event. The required paperwork is outlined later in this packet.

Training Requirement

All volunteers must complete all Levy training programs before being able to participate at an event, this includes but not limited to Creating Legends, Regulatory Compliance Alcohol Services, and Non-Profit/Concession Training. Several training sessions are provided prior to the beginning of the season and others are scheduled periodically throughout the season as needed. The required training is outlined later in this packet.

Home Games

All games are broadcast on the Cleveland Browns Radio Network

For a typical event, the arrival requirements are as follows:

Game Starts:	1:00PM	7:30PM	8:00PM
Gates Open:	11:00AM	5:30PM	6:00PM
Stand Leads and Co-Stand Leads arrive:	8:30AM	3:00PM	3:30PM
Remainder of group volunteers	9:00AM	3:30PM	4:00PM

Uniform Requirements

Each organization will be responsible for making sure that their volunteers are in proper uniform one hour prior to gates opening. The proper uniform consists of:

- * Levy issued collared shirt, hat and name badge – clean and neat.
- * Khaki pants, neat and clean. Jeans, Cut-offs, Shorts, and Sweat Pants are STRICTLY PROHIBITED.
- * Closed toe, rubber soled, slip-resistant shoes – in good condition (no holes). Sandals are NOT permitted.
- * Hair that is shoulder length or longer must be pulled back.

Levy will provide the shirt on event day. All organizations will be issued a set of hats at the beginning of the season at no cost. If a volunteer comes to the game without a hat there will be ones available for purchase. The volunteer must be dressed in all other aspects of the uniform upon entering the gates for check-in. Anyone not wearing the proper uniform will be asked to leave.

Stand Assignments

The assignment of stands is in Levy's sole discretion and based on prior volunteer history and current commitment and performance. At the beginning of a season, the groups that met commitment requirements for the previous season will have first choice of stand assignments.

To maintain these assignments, the groups will have to meet or exceed the current season's commitment and requirements. No one is guaranteed a stand placement for the entire season and groups should not expect to remain in the same stand for all events. Game day assignments are not released prior to the event.



Required Paperwork

The following outlines all of the paperwork that must be completed or provided before participating in your first event:

Non-Profit Tax Exempt Status

Each organization must certify that they are a Not-For-Profit, tax exempt organization as defined by the Internal Revenue Service Section 501(c)(3) of the Internal Revenue Code. The group must provide a Letter of Determination recognizing the organization as tax exempt. Churches and schools may provide a Letter of Determination or State Exemption certificate. If the group name does not match the name on the certificate or Letter of Determination, additional documentation will be required. The group must operate for civic, charitable, religious, or educational purposes.

Group Insurance Requirements

Each organization is responsible to provide insurance coverage as set forth in the Non-Profit Services Agreement. The organization must provide a certificate of insurance that will be kept on file for the duration of the contract. If the organization is not able to provide the required certificate of insurance, 2% of net sales will be deducted on an event basis.

Non-Profit Group Service Agreement

Each group must sign an agreement that outlines the policies and procedures that must be followed. A copy of your Federal Tax Identification Number must be furnished with the signed service group agreement.

Letter of Intent to Volunteer

All non-profit group members must sign a written statement declaring their intent to volunteer and donate their services to Levy Restaurants. All volunteers must sign this at every event.

Description of Non-Profit Organization

All non-profit groups must provide a brief description of their organization in advance and detail what the money raised will be going towards.

Federal Tax Requirements

All organizations must provide a completed W-9 to receive payment.

Age Requirement

All non-profit group members must be at least 18 years of age to volunteer with Levy Restaurants. Volunteers that serve or sell alcoholic beverages or participate as a cashier must be at least 21 years of age. Each volunteer is required to present a valid picture ID (showing date of birth) upon checking in for each event.

Training Requirements

Levy Restaurants will supply training to all group members to ensure proper management and great guest service in all of the concession locations. Levy Restaurants will train workers on: inventory procedures, guest service, responsible alcohol training, cash handling, and food preparation.

In addition, group leaders and group members who are working with Levy Restaurants are required to attend all Levy training sessions before participating at any event.

Orientation and Training Classes

Creating Legends

Learn what makes Levy Restaurants a great team! Discuss policies and procedures, customer service, appearance guidelines, and basic facility rules and regulations.

Operational and Guest Service Training

Learn how to operate a concession stand – from cash registers to cooking equipment. Discuss inventory control, paperwork completion, and proper cash handling procedures. Learn the check-in/out procedures, staffing tips, appropriate food safety and sanitation measures, food preparation, and how to Win One Customer At A Time!

Regulatory Compliance Services: Alcohol Training

All volunteers of Levy Restaurants are required to complete the alcohol service training prior to volunteering. Volunteers must submit confirmation to their group leaders before the volunteers can work. All new team members/volunteers must participate in a training session through the online training. The following topics will be covered:

- 1. Proper Identification Checking/Minors**
- 2. Intoxicated Patron/Intervention**
- 3. Illegal Drug Activity Prevention**
- 4. Responsible Service of Alcoholic Beverages**
- 5. Local & State Laws/Ordinances**
- 6. House Policies**
- 7. Proper Management Practices**

2010 Donation Structure

Outlined below is the donation structure for the 2010 season. This structure applies to all events. Levy management reserves the right to add additional bonus criteria to special events.

Standard Donation Payout

EXAMPLE:

Concession Stands

Food and beverages 10% of Net Sales

*** \$200 minimum donation on all locations**

** Minimum staffing requirements must be met to receive minimum payout*

** PLEASE NOTE: Group will be deducted 2% if the organization can not provide the insurance requirements set forth by Levy Restaurants*

Donation Payout Example

Total Gross Sales: \$11,000.00

Base Donation: \$1,100.00

Sample Game Day Bonus 1: Shortest Transaction Time: \$50.00

Sample Game Day Bonus 2: Closest Inventory Stand Sheet to Cash: \$100.00

Total Donation: \$1,250.00

PLEASE NOTE: 2% will be deducted from Food and Beverages Net Sales if the organization can not provide the insurance requirements set forth by Levy Restaurants. There will be % deductions established on overall performance of the group and attention to detail.

Payment Structure

In addition to the standard donation payout, each group may be eligible for incentive bonuses on an event by event basis. The total incentive amount will be paid to the group on the current event check. The Levy Concessions Supervisor will be responsible for recording and signing off if the bonus criteria were met at the designated time. This will be turned into the Volunteer Coordinator at the end of the event. The Volunteer Coordinator and other members of the Concession Management team reserve the right to override the decision of the supervisor on all bonus decisions.

Want to Receive a Larger Donation?

You can receive a larger donation for your organization if you can provide extra volunteers. If you have more volunteers than needed to staff your primary location then those extra individuals can volunteer in other stands and receive an additional donation for their efforts.

2010 Pyramid Savings Plan

This is your opportunity to make your hard work and effort pay off even more as the season progresses! Over \$65,000.00 was paid out in extra donations during the 2009 season. Starting with the first pre-season game, 1% of your total net sales will be set aside in your very own "Holiday Payout" account. This account will continue to grow as long as you continue to volunteer at the eligible events and meet all requirements. If your organization misses one of the events, your account balance returns to zero and you start all over again.

EXAMPLE:

Here is a list of the eligible events:

- Volunteer at all 10 home Browns Games
- Volunteer at all home playoff games (if applicable)
- Volunteer at all additional events at Cleveland Browns Stadium (if applicable)

Requirements:

- You must meet all regular donation and bonus criteria on an individual event basis to be eligible for the Holiday payout.
 - No game substitutions will be allowed. If the circumstance arises that a group was willing to volunteer at an event and the event was fully staffed, the group will be given credit for that event only if the group showed up at the event to be used as backup and was not utilized. The group will receive the minimum donation of \$200.
 - You will receive your Holiday payout on a separate check after the end of the season.
- Decisions on the Holiday payouts are at the final discretion of the Levy management team.
